

## **SuperTalk Mississippi Harry Connick, Jr. Concert Ticket Giveaway Contest Rules**

### **1. Eligibility**

SuperTalk Mississippi Harry Connick, Jr. Concert Ticket Giveaway Contest Rules (the "Sweepstakes") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of TeleSouth Communications, Inc d/b/a SuperTalk Mississippi Media and other companies associated with the promotion of the Sweepstakes, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. ### **2. Sponsor**

Online via the SuperTalk Mississippi App: This method of entry will be available by visiting the SuperTalk Mississippi App and following the directions provided to fill out the entry information, and submit.

Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

## **6. Prize Drawing**

## **9. General Conditions**
